## WC-CMD-ACMF Joint Sustainable Finance Working Group Industry Advisory Panel

The ASEAN Capital Markets Forum (ACMF) and the ASEAN Working Committee on Capital Market Development (WC-CMD) are pleased to announce the appointment of the ACMF-WC-CMD Joint Sustainable Finance Working Group (JSFWG)'s Industry Advisory Panel (IAP) Members for the 2023/2024 term.

ACMF and WC-CMD established the IAP in 2021 with the aim of engaging with and receiving feedback from the private sector on ACMF and WC-CMD's sustainable finance agendas and initiatives. The IAP is intended to provide ACMF and WC-CMD a better understanding and insights into the views, ideas, and needs of the private sector, while also serving as an avenue for ACMF and WC-CMD to share their perspectives with the industry.

The 2023/2024 IAP structure incorporates two enhancements to the IAP. At its inception, four IAP working groups were created - Taxonomy, Transition Standards, Disclosures, and Strengthening Demand and Supply for Sustainable Finance. These working groups reflected the priorities for sustainable finance in ASEAN. As progress was made in addressing the Disclosures facet for sustainable finance, the Working Group on Disclosures branched into two subgroups, Sustainability Reporting and Data for Disclosures, to address the growing importance of reliable, consistent, and comparable data for meaningful disclosures. While the Taxonomy and Transition Working Groups have been closely working together, given the significant interrelationship between their work, they will now be formally consolidated. This consolidation will enable the enlarged Working Group to address these interrelated areas more holistically and effectively, at the same time optimising the use of resources. The second enhancement to the IAP structure is the inclusion of observers into the IAP. The inclusion of observers will contribute to building capacity, especially for the Cambodia, Lao PDR, and Myanmar ("CLM") markets. The 2023/2024 IAP will start with three observers. The Sustainable Finance Institute Asia (SFIA) will continue to be the convener of the IAP.

"The IAP has proven to be a valuable interaction point for the capital market regulators and industry in advancing the important regional sustainable finance agenda and we hope that the IAP will play a bigger role in accelerating the agenda moving forward," said the JSFWG.
